The share of Youth Festival fees for **Revenue District** level Arts Festival is to be remitted to the concerned Deputy Director of Education of the Revenue district where the school belongs.

The principals of Higher Secondary Schools are directed to draw the share of share of Youth Festival fees for the **state level festival** at the rate of Rs.6/- per student and to forward the same by means of crossed Demand Drafts payable at Thiruvananthapuram drawn in favour of “**Director of Public Instructions**” payable at the State Bank of Travancore, Vazhuthacaud, Thiruvananthapuram.
